DIRECTIONS FOR USE

Shake well before using.

All Natural Snail & Slug Spray RTU controls snails & slugs by contact or as a repellent. It is a good choice for preventative control. It is active over a wide range of temperatures and can be applied up to day of harvest.

Apply **All Natural Snail & Slug Spray RTU** directly to the snails & slugs for contact control. As a repellent, apply directly to the plants to be protected when feeding is first noticed. Apply in the late evening for best results.

All Natural Snail & Slug Spray RTU can be used repeatedly on an as needed basis.

USE SITES

Vegetables (such as, but not limited to): Fruiting vegetables, cole crops, leafy vegetables, cucurbits, root and tuber vegetables, herbs and spices, etc.

Small Fruits & Berries (such as, but not limited to): Strawberries, cane berries, blueberries, currants, etc.
